## Tenable Capture the Flag Contest Official Rules

## No Purchase Necessary to Enter or Win

- 1. Overview. Tenable, Inc and its subsidiary offices ("Tenable") have created a contest where Entrants, whether individual or through the formation of a team, will participate in a series of security-related challenges to earn various amounts of points (the "Contest"). The Contest will be available to Entrants both virtually and at the locations set out in the conclusion of these Official Rules. The first individual or team to complete each challenge will win points. The individual/teams that earn the most points at the conclusion of the Contest will win recognition as a winner and prizes (pending Eligibility as defined in Item 2 below). In case of a tie, the team who scored the winning amount of points first, will win the Contest. The Contest is sponsored by Tenable and begins on August 9, 2023 at 12:00 am EDT. Entries must be submitted during the Contest Entry Period (as defined below) to Tenable in strict accordance with Tenable's instructions and these Official Rules. Entrants are limited to a single entry, either as an individual or as part of a team, during the Contest Entry Period. Teams should only register one account for the team. Each team member's information must be provided in accordance with the team registration process. There is a maximum limit of five (5) individuals per team. Those who do not abide by these Official Rules or Tenable's instructions, or the prize fulfillment requirements, may be disqualified at Tenable's sole discretion. Chat Bot on Tenable.com is not part of the event and participants may not communicate through the Chat Bot, nor may any artificial intelligence be used. Tenable may keep all Entrant information after completion of the Contest for business management and record keeping purposes and in accordance with Item 11 of the Official Rules.
- 2. **Eligibility.** The Contest is open to individuals who are over the age of eighteen (18) years and, who are residents of countries not listed on the OFAC Sanctioned Country List. However, only those Entrants who reside in Australia, the United States, or Singapore will be eligible to claim a prize for the Contest. Employees of Tenable and/or the immediate family (spouse, parents, siblings and children) and household members (whether related or not) of each such employee, and federal and state government employees are not eligible to win the prizes described herein. No entry fee is necessary to participate in the Contest. All international, U.S., federal, state and local laws and regulations apply and this Contest is void where prohibited by law.

The Contest is no way sponsored, endorsed, or in association with the vendors of prizes associated with this contest, including, but not limited to Amazon, Inc. or its affiliates. Each Entrant completely releases and absolves each prize vendor and their affiliates from any

- 4. **Agreement to Official Rules.** Participation in the Contest constitutes Entrant's full and unconditional agreement to, and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 5. **Contest Entry Period.** The Contest begins on Aug 9, 2023 at 12:00 am EDT and ends on Aug 10, 2023 at 11:59 pm EDT (the "Contest Entry Period").
- 6. **Entry.** To enter the Contest, eligible entrants must fill out and submit the event registration form, which can be accessed directly on the competition platform CTFd.io (<a href="https://tenable.ctfd.io/">https://tenable.ctfd.io/</a>) or through the official event landing page (<a href="www.tenable.com/events/capture-the-flag">www.tenable.com/events/capture-the-flag</a>). They will then create a username and password to access the challenges when the Contest opens (each an "Entrant"). The Contest is limited to one entry per person, either as an individual or as part of a team. There is a maximum of 5 individuals per team. Multiple entries by a single Entrant may void eligibility.
- 7. **Physical locations.** Entrants may choose to physically attend at the following locations where the Contest will be hosted:

- 8. Winners. The winners will be determined on August 14, 2023 at 12:00 pm EDT. Tenable will identify the winners by totaling points earned. Additionally, a game within the game may be offered where completed tasks will earn points toward an Entrant receiving Tenable apparel. Points for each challenge may vary, some may be awarded on a first-come, first-served basis, others with a set value or decreasing value over time. Accepting hints for a challenge may reduce the amount of points awarded. If a potential winner did not comply with the Official Rules of this Contest, their entry will be void and Tenable will select an alternate winner in his/her place by selecting the Entrant with the next highest point total received during the Contest Entry Period. If a potential winner is not eligible for prizes, Tenable will recognize their efforts via virtual acknowledgment but the prize will go to the Entrant with the next highest point total received during the Contest Entry Period.
- 9. **Prizes.** There will be three (3) winners receiving a virtual gift card with a retail price of approximately \$500, \$300 and \$200, for first, second and third place, respectively. Only one prize will be awarded for each winning Entrant. If the winner is a team, the team will only

receive one prize to be given out or shared amongst participants at their own discretion. Tenable apparel or other commemorative event merchandise may also be won if the Entrant meets certain requirements within the Contest. Tenable will notify the potential winners via email to the email address that the Entrant provides during registration. The potential winner will have seventy-two (72) hours to confirm they are the winner. If a potential winner does not respond within seventy-two (72) hours of the date Tenable has notified Entrant, Tenable shall choose an alternate winner from the remaining eligible entries. Winners may be required to provide evidence of identity in connection with claiming the prize.

If legitimately claimed, the prize will be awarded. All taxes, social security payments or other fees (including those applicable in your jurisdiction of primary residence) and other expenses not specified in these Official Rules as being provided as part of the prize are the sole responsibility of the winners.
