## 1. INTRODUCTION

This Services Brief ("Brief") incorporates and is governed by the Master Agreement located at <a href="http://static.tenable.com/prod\_docs/tenable\_slas.html">http://static.tenable.com/prod\_docs/tenable\_slas.html</a>, or any negotiated agreement between the parties that covers Professional Services ("Agreement"). Any capitalized terms used herein but not defined will have the definitions ascribed to them in the Agreement.

Any installation, configuration, knowledge transfer, or instruction not specifically referenced in this Brief is considered out of scope for this engagement. This includes, but is not limited to, any integrations related to third party products.

## 2. SERVICE OVERVIEW

Tenable Security Center (formerly Tenable.sc) Quick Start Deploy services accelerate configuration and integration to a fully operational capability of Tenable Security Center. The service allows your organization to realize several key benefits of Tenable Security Center in a short period of time.

This Quick Start Service is designed to provide three (3) outcomes within the scope defined in this Brief:

- (a) **Install and configure Tenable Security Center**. Tenable Security Center and Tenable Nessus will be installed and configured based on requirements captured during the solution design.
- (b) **Implement best practices**. Experienced Tenable Engineers ("Engineer") will implement and orient you to Tenable's best practices for enterprise deployment.
- (c) Validate operational capabilities. Tenable Security Center will be tested end-to-end for scanning and other operational capabilities.

### Prerequisites

In order to receive the Quick Start Services, the Customer must ensure before Tenable begins work that all of the following have been performed, is available or is accessible as applicable:

- (a) Tenable software covered by this Brief is downloaded and accessible to Engineer
- (b) Customer has valid activations and licenses for software applicable to this Brief
- (c) Tenable port requirements have been reviewed at <a href="https://community.tenable.com/s/article/What-ports-are-required-for-Tenable-products">https://community.tenable.com/s/article/What-ports-are-required-for-Tenable-products</a> and the necessary ports are open
- (d) Access to Tenable's Community and/or Support Portal
- (e) All necessary hardware and appliances are mounted and in place
- (f) Customer network topology diagram and information
- (g) List of Customer hosts that can be actively scanned

- (h) Administrative credentials for Customer hosts to be scanned
- (i) Customer SMTP server information (if applicable)
- (j) Customer LDAP server information (if applicable)
- (k) Customer desired Tenable Security Center user list

#### **Definitions**

#### **SMTP**

Simple Mail Transfer Protocol - an Internet standard communication protocol for electronic mail transmission.

#### LDAP

Lightweight Directory Access Protocol - an industry standard application protocol for accessing and maintaining distributed directory information services over an Internet Protocol (IP) network.

## 3. SCOPE

This Quick Start service is scoped by two categories: Installation and Configuration, and Operational.

#### Installation and Configuration

Engineer will perform the following installations and configurations:

- (a) Install one (1) instance of Tenable Security Center
- (b) Install up to seven (7) Tenable Nessus sensors
  - (i) Sensors include Tenable Nessus Agents, Tenable Nessus Scanners, Tenable Nessus Manager, and Tenable Nessus Network Monitor
- (c) Configure up to four (4) scan zones
- (d) Configure up to three (3) repositories
- (e) Connect Tenable Security Center to one (1) SMTP server
- (f) Connect Tenable Security Center to one (1) LDAP server
- (g) Configure one (1) organization
- (h) Configure one (1) full access group
- (i) Create up to four (4) users admin, security manager, and two (2) others

#### Operational

Engineer will create and demonstrate the following in Tenable Security Center:

(a) Up to four (4) scans and scan policies

- (b) Up to eight (8) asset lists four (4) static and four (4) dynamic
- (c) Create one (1) CIS Compliance scan based upon one (1) pre-existing benchmark
- (d) Up to four (4) custom saved queries
- (e) Up to four (4) dashboards from software templates
- (f) The use and creation of up to four (4) dashboard elements including the Matrix
- (g) Up to four (4) reports from software templates
- (h) Up to one (1) custom report
- (i) The use and creation of report elements including the Iterator
- (j) Up to four (4) Assurance Report Cards from software templates
- (k) One (1) custom Assurance Report Card limited to a maximum of three (3) policies
- (I) Up to four (4) alerts

## 4. DELIVERABLES

A single master deliverable document containing three parts (shown below) will be completed as part of the engagement:

- (a) Configuration document summarizing the configuration of Customer's installation with descriptions for each configuration
- (b) Future recommendations
- (c) Links to appropriate documentation

## 5. ASSUMPTIONS AND CONSTRAINTS

Tenable will rely on the following assumptions, together with those stated elsewhere in this Brief, in performing the service in this Brief.
